Portrait group/Still Life Barbara (for Lura)

Our first portrait group session was held at the community college. There was a good turnout and it worked well. The college is also providing table-top easels for people to use. Darren Soukup at the college also offered the classroom next door for the still-life group. Kerby and Lura are also speaking to him about being a possible venue for demos and general meetings. We cannot use the space when food is involved, so we will see how much we will need to book the senior center next year.

Plein air Mary Beth Harrison

Mary Beth reports that there has been very good turnout for the Plein Air venues, with new people coming also. Seventeen people have signed up for the bonus Plein air session 11/1/23 at Erna's Elderberry House.

11/8/23 is the regularly scheduled Plein Air event, which will be held at Casto Oaks Winery, Mariposa.

Mary Beth brought up the idea of a Plein air art show fundraiser this time next year.

- Photo Group Jennifer Moss Jennifer will be communicating with Autumn regarding planning an in-person meeting in November at Stellar Gallery. Jennifer is looking into getting a screen for showing photographs during the group meeting.
- Still Life Barbara Liss
  Nicole has been setting up still life vignettes for the Still life group, but Barbara reports that Nicole is somewhat discouraged with the small turnout. Barbara stated that if Nicole doesn't continue in this role then Barbara will see that still life setups continue, since they are important to her.
- Classes

14 people showed up for the 1st class; 0 for the 2nd class and 2 for the 3rd class (given by Juliet). Board discussed that pre-payment for classes is beneficial so the instructor knows how many people to plan and prepare for, besides getting students to commit. The room at Raleys is booked for November 14 and November 28th.

Intensive workshops will be held at Bodys by Boyds on weekends. The first workshop, basket weaving offered by Carolie Jensen, will be the last weekend in January. Carolie says she knows of six people who want to sign up so far; she feels the space can accommodate up to 12.

• Galleries & Events

**YGAC** (Yosemite Gateway Art Center) – YSA Showcase: Carolyn Hartling reported that Jennifer Moss, Kerby Smith and Gina Mims are currently showing in the YSA space at YGAC. This exhibit will be up until mid-November at which time a new exhibit will be installed. Already signed up is Becky Alarcon, with space for two additional artists. That exhibit will be up from mid-November to mid-January.

### Visitor Center:

Gina is currently exhibiting; the next artist showing will be Sandee Scott through the end of December.

#### Old Business:

Our Artober booth at the Fall Festival was discussed. Monica Lasgoity, Jim Morris, Cathy Desch and others volunteered to oversee our booth. A couple of the artists sold work there; all talked up YSA to interested parties. Monica stated she felt it was worth it, but personally wouldn't do it 2 days in a row again. Overall, in spite of being during the same time as Sierra Art Trails, the conclusion was that it was a successful event for YSA.

## New business:

- 1. Monica has forms from the postal service to apply for special mailing rates for non-profits.
- 2. Madera County Art Center is holding their fundraising gala on December 3rd at The Vineyard Restaurant. Barbara suggested and recommended that 2 representatives from YSA attend, and proposed that YSA cover the \$125 per person cost for 2 people (herself and Gina Mims). MCAC has been quite supportive, monetarily and in other ways, of YSA plus it is an opportunity to network and promote YSA. The board unanimously approved the expenditure of \$250.
- 3. The Celebration of Life for Norma Rogers is being held 11/12/23 at 1:00 pm at the Oakhurst Community Center and all are invited. Announcements with this information will be made to the membership.
- 4. The YSA Holiday party will be 12/16/23 at the Oakhurst Community Center. It will be a potluck. Discussion ensued about the activities during the party it was concluded that we will do gifts again, but no show-and-tell due to time constraints.
- 5. Carolynne Gamble's collage card-making class is 11/1423 at Raleys, 6 8 pm. Jennifer has set up on-line "ticketing" for people to sign up and pay online.
